

TERRITORIAL TABLE OFFICIAL RULES

1. Dates:

- a. Contest entry begins Tuesday, November 4, 2014 12:01am MST
- b. Contest entry ends Friday, November 28, 2014 5:00PM MST

2. Eligibility:

- a. You must be a legal resident residing in Arizona (proof of residency required).
- b. You must be 18 years of age or older at time of entry.
