**1. Dates:**

- a. Contest entry begins Wednesday, March 11, 2015 12:00am MST
- b. Contest entry ends Wednesday, March 25, 2015 5:00pm MST

**2. Eligibility:**

- a. You must be a legal resident residing in Arizona (proof of residency required).
- b. You must be 21 years of age or older at time of entry.
- c. No purchase necessary to participate or win. Purchase will not improve chances of winning.
- d.
