

## **Jump for Bowl Tickets**

### **OFFICIAL RULES**

Cactus Bowl tickets, Fiesta Bowl tickets, Pro Bowl tickets, and Super Bowl tickets

**1. Dates:**

- a. Contest entry begins Monday, November 3, 2014 12:01am MST
- b. Contest entry ends Sunday, February 1, 2015 5:00PM MST

**2. Eligibility:**

- a. You must be a legal resident residing in Arizona (proof of residency required).
- b. You must be 18 years of age or older at time of entry.
- c. No purchase necessary to participate or win. Purchase will not improve chances of winning.
- d.
