1. HOW TO ENTER

- a. These rules govern the Phoenix Suns vs Orlando Magic Ticket Giveaway ("Contest"), which is being conducted by KMVP FM & KTAR FM ("Station"). The Contest begins on Friday, January 28, 2022, and ends on Friday, February 4, 2022 ("Contest Dates"). Entrants may enter via mail or online only.
- b. To enter the Contest, entrant may enter online beginning on Friday, January 28, 2022, 2021 at 12:01am MST and ending on Friday, February 4, 2022 at 5:00pm MST ("Entry Period").
 - i. To enter the Contest online, visit <https://arizonasports.com/story/2986821/win-a-pair-of-tickets-to-the-phoenix-suns-vs-orlando-magic/> and follow the instructions and complete and submit the online entry form during the Entry Period outlined above. Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Multiple participants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator. Entrants may be given the opportunity to receive marketing communication from contest sponsor(s). OR VIA MAIL: Hand print your name, address, phone number and email address and provide your signature (your signature certifies that have read and complied with all of the Official Rules of this Sweepstakes) on a 3" x 5" card, and mail your entry to: 2022 Phoenix Suns vs Orlando Magic Ticket Giveaway Sweepstakes, c/o Arizona Sports 98.7 FM, 7740 N. 16th Street, Suite 200, Phoenix, AZ 85020. All entries must be received and recorded during the Sweepstakes Period.
- c. Only one (1) entry per person is permitted regardless of the method of entry.

- d. All mail and online entries must be received by the end of the Entry Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Arizona, Eighteen (18) years of age or older, and who reside in Maricopa County. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. Unless the Station otherwise specifies, in its own discretion, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize in the last thirty (30) days are not eligible to participate. These restrictions also apply to immediate household members of contest or prize winners. The Station, in its sole discretion, may allow persons who have previously won a prize to be eligible to win another prize without any time restrictions.

- f. This Contest is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

3. PRIZES

- a. One (1) Winners will each receive one (1) Pair of tickets to the February 17 2022, Phoenix Suns vs. Orlando Magic game (ARV: \$175). Winners are responsible for

all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s).

- b. All sales, prizes and other taxes, gratuities and any other incidentals associated with the prizes are the sole responsibility of the prizewinner(s). Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability, in which case, a prize of equal or greater value will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station/judges are final.
- c. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.

Odds of winning depend upon the number of eligible entries received during the applicable Drawing Period. All tickets will need to be redeemed electronically via the Phoenix Suns App or through a Ticketmaster account. Prizes not related to event tickets may be picked up at the office of the Station at 7740 N. 16th Street, Suite 200, Phoenix, AZ 85020 by appointment only (to make an appointment, contact 602-200-2622) between 8:30 a.m. – 1:30 p.m. and 2:30 p.m. - 5:00 p.m. If a winner chooses to have a prize shipped or if the station chooses to ship the prize, the Winner will be required to sign a release that the Station and any Released Parties (defined below) are not responsible if the prize is late, lost, stolen, misdirected, undeliverable, or damaged during shipping. In such cases, there is no purchase necessary to enter or win, except for reasonable postage and handling fees the amount of which shall not exceed \$1.50 plus the actual cost of postage to ship the prize.

- 5. Decisions of the Station management with respect to the Contest are final.

- a. Public health conditions do not permit Winner(s) to claim their prize(s) at the office of the Station. Therefore, the Station will coordinate with the Winner(s) to confirm their identity remotely and to deliver the prize by mail or other means of delivery. If a potential Winner(s) is deemed ineligible for any reason, cannot be contacted, fails to sign, and return the fully executed affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential inner forfeits the prize(s). a. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good-faith determination that an entrant has cheated or committed fraudulent activity in connection with a Contest, the Station may disqualify that entrant from entering and/or winning this and any or all future Station-administered contests and seek damages to the fullest extent permitted by law.

b. The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the Contest,

including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. To the extent the Station makes material changes to the terms and conditions of the Contest, any such material changes will be broadcast on the Station and/or posted on its website: ArizonaSports.com within twenty-four (24) hours of the change and periodically thereafter. If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but does not have the obligation, to cancel, terminate, suspend, or modify the Contest and shall not be required to award a substitute prize(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the Contest webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.

successors, employees, participating Contest Sponsors, agents and all others connected with them and the Contest (the "Released Parties") from any and all liability, claims, actions, and damages sustained or incurred by participation in the said Contest, and the receipt and use of any prize(s) awarded (if any) through such Contest arising in any manner whatsoever, including but not limited to an act or omission, whether negligent, intentional or otherwise caused by Station, its affiliates, parents, assigns, successors, employees, sponsors, agents and all others connected with them and the Contest.

- f. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering, or the administration of the Contest or in the announcement of a prize; (ii) incorrect or inaccurate information, human error, failure, or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, illegible, incomplete, or late entries; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone service outages, delays, busy signals, poor signals or signal interference, accidental disconnection, equipment malfunctions, and any other technological failures; or (vi) any cancellations, delays, diversions, or substitutions or omissions by any transportation providers or any other persons or entities providing any services to Entrant(s) and/or winner(s) (and winner's guest(s) if applicable) including any results thereof such as changes in services or location necessitated by same.
