**1. Dates:**

- a. Contest entry begins, Monday, May 15, 2017 12:01 am MST
- b. Contest entry ends Friday, May 26, 2017 4:15PM MST

**2. Eligibility:**

- a. You must be a legal resident residing in Arizona (proof of residency required).
- b. You must be 18 years of age or older at time of entry.
- c. No purchase necessary to participate or win. Purchase will not improve chances of winning.
- d. You may not participate if you are an employee or agent of Arizona Sports 98.7 FM, (“Station”) their employees, authorized dealers, their affiliated companies, advertising and promotion agencies, or any entity associated with the sponsorship or conduct of the contest, or if you are an immediate family member of any such employee or agent so situated (immediate family members include spouses, siblings, parents, children, grandparents, and grandchildren, whether as “in-laws”, or by current or past marriage, remarriage, adoption, co-habitation or other familial extension, and any other persons residing at the same household location, whether or not related).

**5. How to Claim Prize(s):**
