- b. To enter the Contest, entrant may enter via Twitter Post or Mail-In Entry beginning on Wednesday, September 2, 2010 at 12PM MST and ending on Wednesday, September 30, 2020 at 5:00PM MST ("Entry Period").
 - i. To enter on Twitter, visit any participating Carl's Jr. location in the Metropolitan Phoenix Area +Tucson and Northern Arizona, make a donation at the register to Phoenix Children's Hospital and in return you will receive an All Star Icon Pin Up that will include a coupon offer. Post a photo of the All Star Icon Pin Up including the hashtag "#Carlsjr4PCHcontest" during the Entry Period. Entrant will need to have a valid Twitter account in order to enter, although the Contest is not sponsored, endorsed, administered by, or associated with, Twitter. If they do not already have one, entrants can open a Twitter account at no cost at www.twitter.com. Limit one (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address or Twitter account. Multiple participants are not permitted to share the same email address or Twitter account. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator. Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Use of Twitter as a means of entry will be subject to that service provider's privacy policy and terms of use. By participating in the Contest, entrant understands that he or she is providing his or her information to Station and not Twitter. Further, entrant specifically agrees to release

Twitter from any and all liability associated with this contest. The contest is in no way sponsored, endorsed or administered by, or associated with Twitter.

- ii. - c. Only one (1) entry per person is permitted regardless of the method of entry. There will be up to a total of One (1) winner selected in the Contest.
- d. All entries must be received by the end of the Entry Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Arizona, eighteen (18) years of age or older, and who reside in one of the Metropolitan Phoenix. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. 3. PRIZES

- a. One (1) prize will be awarded One (1) \$300 Carl's Jr. Gift Card and an autographed Arizona Cardinals Football (ARV: \$100) The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s).
- b. All sales, prizes and other taxes, gratuities and any other incidentals associated with the prizes are the sole responsibility of the prizewinner(s). Prizes are not transferable or exchangeable for cash and may not be substituted, except by sponsors for reasons of unavailability, in which case, a prize of equal or greater value will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station are final.
- c. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.
- b. Each individual Twitter Post and/or Mail-In Entry will be numbered in the order they are posted and/or received. One (1) prize winner will be selected on Thursday, October 1, 2020 in a random drawing of all eligible entries received during the entry period.
- c. Odds of winning depend upon the number of eligible entries received during the applicable Drawing Period.
- d. All prizes may be picked up at the office of the Station at 7740 N. 16th Street, Suite 200, Phoenix, AZ 85020 by appointment only. If due to reasons beyond the control of the station, a prize needs to be mailed or shipped, the Winner may be required to sign a release that the Station and any Released Parties (defined

below) are not responsible if the prize is late, lost, stolen, misdirected, undeliverable, or damaged during shipping.

- e. Potential winner(s) will be notified of winning by Twitter message and/or telephone at the time of the drawing. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good-faith determination that an entrant has cheated or committed fraudulent activity in connection with a Contest, the Station may disqualify that

- b. 7. Any violation of these rules may result in disqualification. Consistent with Section 1(e), only one (1) entry per person.
