#### 1. HOW TO ENTER

- a. These rules govern the Coors Light Sun Devil Gift Pack ("Contest"), which is being conducted by KMVP ("Station"). The Contest begins on September 1, 2020 and ends on December 31, 2021 ("Entry Period"). There are three ways in which you can be entered to win this contest.
  - i. To enter the contest automatically, purchase a Sun Devil Combo Deal at any Valley Venezia's Pizzeria <https://www.venezias.com/locations/> beginning on Tuesday, September 1, 2020 at 12am, MST and ending on Thursday, December 31, 2020 at 5:00pm MST ("Entry Period") and you will automatically be entered into the contest
  - ii. To enter the Contest via text message beginning on Tuesday, September 1, 2020 at 12am, MST and ending on Thursday, December 31, 2020 at 5:00pm MST ("Entry Period"). Text the Keyword "PIZZA" to 620620. Only one entry per Keyword per person is permitted. By texting to enter the Contest, the entrant consents to receive automated messages about the Contest on his or her cell phone. Standard message and data rates may apply. The frequency of automated message(s) that an individual may receive after entering the Contest may vary.

Terms are available at the Station's Terms of Use. Station assumes no responsibility for charges incurred for text messaging, including, without limitation, any text messages or Contest notices from the Station. To be eligible to win, entrants in the Contest must provide all information requested including but not limited to entrant's full name, complete address (including zip code), day and evening phone numbers, and date of birth to verify eligibility. P.O. Boxes are not permitted as addresses.

- iii. All entries must be received and recorded during the entry period.
- b. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- c. Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process, but membership/participation is not required to enter the contest.
- d. Only one (1) entry per person is permitted regardless of the method of entry. There will be up to a total of Four (4) winner(s) selected in the Contest.
- e. All entries must be received by the end of the Entry Period regardless of the entry method.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Arizona, twenty-one (21) years of age or older, and who reside in Maricopa County, Arizona. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

Each prize consists of Two (2) YETI/Coors Light hats (ARV: \$40.00), Six (6) Koozies (ARV: \$2.50), Two (2) Coors Light/ASU Aluminum Cups (ARV: \$4.00), One (1) Coors Light/ASU Rally Flag (ARV: \$10.00), One (1) Coors Light YETI Cooler Bag (ARV: \$220.00), Two (2) ASU Tailgate Chairs (ARV: \$60.00) and One (1) Patio Umbrella (ARV: \$75.00). The winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s).
- b. All sales, prizes and other taxes, gratuities and any other incidentals associated with the prizes are the sole responsibility of the prizewinner(s). Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability, in which case, a prize of equal or greater value will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. - c.   - One (1) prize winner will be selected on Monday, November 2, 2020 in a random drawing of all eligible entries received between Tuesday, September 1, 2020, 12:01am, MST and ending on Monday, November 2, 2020 at 12:01am MST.
  - One (1) prize winner will be selected on Tuesday, December 1, 2020 in a random drawing of all eligible entries received between Tuesday, September 1, 2020 at 12:01am MST and ending on Tuesday, December 1, 2020 at 12:01am MST.
  - One (1) prize winner will be selected on Monday, January 4, 2021 in a random drawing of all eligible entries received between Tuesday, September 1, 2020 at 12am, MST and ending on Monday, January 4, 2021 at 12:01am MST.

In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any prize or prizes. services to Entrant(s) and/or winner(s) (and winner's guest(s) if applicable) including any results thereof such as changes in services or location necessitated by same.
